**ENTRIES:** Entries on the standard entry form (see below) shall be submitted to SMWYC by the mandatory Skippers Meeting to be held at 1030 hours before the start of the first race on race day. A \$10.00 entry fee will be payable at time of entry.

**CLASSES:** Junior A, B and C US or Sydney Sabots.

**SCHEDULE:** There will be seven races with the first start at approximately 1100 hours. There will be no makeup races. *Race participants are invited to enjoy SMWYC's hospitality lunch on race day.*

**COURSES:** Will be selected from SMWYC's Inside Race Chart to be distributed on race day.

**RULES:** The Racing Rules of Sailing as modified by the Race Committee and the US Sabots Association. Rules 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe, is required.

**SCORING:** When fewer than seven races have been completed, a boat's series score will be the total of her race scores. When seven or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

**TROPHIES:** THE MUDDY FEET SERIES PERPETUAL will be awarded to the best A, B and C sailors of the Regatta and take home for the top three sailors of each class.
